Senate Inquiry report

On 5 September 2023, the Senate Inquiry into Concussion and Repeated Head Trauma in Contact Sport handed down its final report. We welcome the recommendations, though we acknowledge that this is only the first step, and there is much work to do from here.

The solutions to this crisis are not necessarily complicated, though it will require effort and political will from governments across Australia to lead the way (or to provide funding for others in the field to do so) in solving these issues.

From our perspective, comprehensive (and face to face) concussion education is one of the ways forward to ensuring we have a concussion literate community, which will give at risk communities (among others) the best chance at properly managing acute concussion and at preventing poor outcomes.

We acknowledge that ongoing research is necessary, though every piece of available money is going to research, and not a single dollar is going to grassroots concussion education. This needs to urgently change.

At its core, this Senate Inquiry report is giving Australia the chance to unite and turn over a dark leaf; to balance the scales. We implore governments across Australia to be pragmatic and brave -- Concussion Australia is in your corner, and we know that we have the necessary expertise and experience to assist with the rollout of the recommendations.

This message is not just targeted as governments, but remains true for all organisations and people operating in this area: work with each other, not against each other. For as long as spears are being thrown, it is the community that suffers. Concussion Australia will release an official response in the coming weeks.

MOU with Brain Injuries Australia

Concussion Australia was pleased to recently sign an MOU with Brain Injuries Australia. Concussion Education Workshop at Banora Point High School

On 28 August 2023 Concussion Australia attended and ran a concussion education workshop for all of the teachers at Banora Point High School. Some of the feedback included:

- 34/36 survey participants felt more prepared to deal with concussion after the workshop;
- 6/36 teachers had been provided with concussion education before, and each of those 6 teachers felt more prepared to deal with concussion in the future (after our workshop);
- Out of 36 teachers, teachers thought that they collectively had 52 concussions, and only 9 of those 52 suspected concussions had been assessed by a doctor or at a hospital.
- 10% of participants (3) recorded that they thought they had 6+ concussions.

The verbal feedback was excellent -- we thank Paul Michael (Chair, CA Medical Advisory Committee) and Isha Cave (volunteer) for running the session. Concussion Australia looks forward to future workshops at schools, with our next one scheduled for 30 October 2023 at Robina State High School.

Some people we have helped in the last three months

Concussion Australia often receives calls and emails from people seeking our assistance. These last few months some of those people included:

- 18 yo concussed from work: we were contacted by Jane's (pseudonym) mother seeking our assistance. We provided referrals to proper medical care with various clinicians across Australia, and an empathetic sounding board for Jane and her mother.
- 10 yo concussion from school: we were contacted by Anne's (pseudonym) mother seeking assistance for her daughter who had a concussion at school. Now months down the track, Anne has been referred for proper medical care, and has been supported in other ways by our team.
- Year 6 student from Tasmania: we were contacted by a year 6 student (after the Senate Inquiry) who wanted to do a research project on concussion. We scheduled a video call, and James (pseudonym) was well on his way to understanding concussion.
